Tax Payment by Credit Card or E-Check: The Town of Bristol is listed with "Official Payments"
 Corporation for those wishing to pay their property tax with a credit card or by e-check. For credit
 card payments, they accept Visa, Master Card, Discover and American Express. Credit card and
 e-check payments must be made via the Official Payments website or by telephone. We cannot
 process credit cards at the Town Hall.

Please be sure you understand the fees involved before making your payment.

## DOG LICENSES MUST BE PURCHASED BY MARCH 31, 2022

Dog license fees have changed for 2022

\$20.00 each for neutered/spayed dogs. \$25.00 for un-neutered/spayed dogs. Kennel licenses are \$55. You can NOT include your dog license fee on the same check with your tax payment or recycle center fee. They must be separate.

For each dog to be licensed, you must <u>provide proof of current rabies vaccination</u>, and complete one of the application forms included below.

## 2022 TOWN RECYCLE CENTER PERMITS

Permits are required for use of the Town Recycle Center. Yearly permit stickers are \$200 and can be purchased at the Town Hall or at the recycle center. Please complete the application supplied below. A sticker for a second vehicle in your household may be purchased for an additional \$20. The stickers are non-refundable, non-transferable and must be adhered to the driver's side of your windshield. You may also pay for a single use of the recycle center. A single use is \$20. Pay the attendants at the recycle center before unloading your items. You can NOT include your recycle center fee on the same check with your tax payment or dog license. They must be separate.
